Broader notion of what forensics should be about.

- 5. Adam Jacobi (Representing NFL) want to engage more between high school/college... continuing in activity is good. Teaming up with PKD. Trying to create a groundswell of interest.
- 6. AFA did approve new code of forensic tournament standards two major components:
 - a. Evidence Not up to date with contemporary practice. Debate/IE split now.
 - b. New whole section on code of conduct. The code of conduct was designed in part as a reaction to what happened in CEDA.
- 7. AFA cosponsoring new journal *Timely Interventions* policy debate generates tons of research and then we tend to throw it away... we know about it, yet it gets buried. Coaches/students shape into articles, not as briefs position/informative briefs. Editorial review board = debaters

- 5-35 years out, big names in a wide variety of fields. Gordon Mitchell (U of Pittsburgh) will be first editor. Free online journal.
- 8. NCA has policy that if you have 25 consecutive yearly memberships, you get to be emeritus... and then your convention fees and membership fees are free. Larry don't have to be retired to check that section for member units/affiliations... the section determines how many programs you have.
