Dear Colleagues:

This is your invitation to attend the Chicken and Egg (El Pollo y El Huevo) Debate Tournament to be held on October 14-15 at the University of North Georgia's Gainesville, GA campus. Please note that this is the Gainesville (not Dahlonega) campus. We plan to have a five round world format tournament (six if entries warrant) in both Spanish and English Language world format (WUDC/CMUDE) format debate this fall. In the past, this has been combined with a preceding NPDA/IPDA event, but we decided to focus this fall on having a quality competition opportunity in world, or "BP" format debating. We will be following the rules of the WUDC and the CMUDE in the respective English and Spanish Language Divisions.

Notes on the Chicken and Egg:

Accommodations—NOTE: There are several events in Gainesville GA this weekend so get your reservations in as soon as possible. Local communities are:

Flowery Branch—within a 10 minute drive.

Lake Lanier—anywhere from 15-20 minutes drive.

Buford (many great facilities near a mall)—around 20 minutes (we are Exit 16 from I-985; Buford is at Exit 4).

Suwanee—within 25 minutes (18-20 mi).

The recommendation is that as you surf around, you ask for properties near I-85 (for the Suwanee properties), or near 1-985 (for Buford). The properties near the Mall of Georgia are your best bet, as restaurants of all descriptions—plus a shopping mall—are right there.

Unfortunately the properties near the UNG campus—Gainesville are booked.

Is the place to find properties in both locations. From there, you can look up individual properties if that is the way that your school wishes your to book.

Please contact tom.preston@ung.edu for ideas of other places to crash. There are other accommodations at Exit 16, as well as one at Exit 12 which used to be a Hampton, but which changed management. Gainesville has many other hotels, but some are less accessible with a short drive to UNG.

Entry Fees: If you can pay cash at registration, too. We will also take credit cards or purchasing cards at the gate, and will provide a means of paying in advance if and when our Extension Division gives us the permission to do so. If you are set up to pay in advance, please contact tom.preston@ung.edu.

The fee schedule is as follows:

- 1) \$65.00 per person for both coaches and students in English Language division.
- 2) Teams must be covered by the n-1 formula for each language. Spanish language teams should bring at least one judge fluent in the Spanish language. Per person fees are WAIVED in the Spanish language division, although in both language, an additional \$50.00 surcharge will be made for each uncovered team.
- 3) Each school must pay a \$25.00 per school fee to defray custodial charges (sorry, but this is a new fee slapped on groups that host events at UNG this year).
- 4) Nuisance Tax--There is a \$50.00 per change surcharge for changes at registration.

The entry deadline is at 5:00 PM ET on Wednesday October 11. Entry fees will be charged as of the entry on that deadline. Please contact tom.preston@ung.edu, though, as we try to accommodate special circumstances.
